Frog Hollow Contract Player's Agreement & Liability Waiver

→ All contract players and captain must sign and return this agreement with their balance due payment. We prefer all of your players to sign the same form below, but if it is not possible, each player can sign their own and return it to their captain.

All forms should be turned in to the captain and mailed together.

1. The court captain is responsible for collecting and remitting court deposits, fees, and membership information for all members of my contract group and myself.
2. Anyone playing in my group more than 3 times must pay a membership. Each non-member guest/sub will be allowed to play 3 times on *any* contract at Frog Hollow before they must either purchase a membership, or pay a \$10 club usage fee on each visit. Captains must ensure that all guests check in at the front desk before playing.
3. Management reserves the right to reassign courts when necessary.
4. Proper tennis attire is required. NO running shoes or black-soled shoes will be allowed while on the court.
5. Children under 12, who are not playing tennis, must be supervised by an adult.
6. We honor VISA, MasterCard, Discover, cash or personal checks for your convenience.
7. No beverages are permitted on the courts. NO smoking is permitted in the facility.
8. Please have **all participants sign this form** and submit their addresses, emails and phone numbers.
9. Contract court fees are refundable only when the court has been resold for the duration of the contract.
10. Turn off all cell phones while on the court.
11. Court etiquette and parking restrictions require that contract court times be adhered to as a matter of courtesy.
12. Frog Hollow has the right to dissolve a contract or membership if:
 - a. Player or players are disruptive or abusive to fellow club or staff members.
 - b. Player or players damage the facility.
 - c. All bills are not taken care of in a timely fashion.
13. In case of an emergency, 911 will be contacted.
14. Frog Hollow will not be responsible for any cash valuables or personal property brought to the club.
15. Courts contracted for lessons: Pro cannot be changed unless another suitable time is available.
16. In case of inclement weather, **contract players must call the club** to determine opening/closing status. If the club is closed during your contract time, a make up contract time will be added to the end of your scheduled contract season on the same day at the same time.
17. Frog Hollow may have programs scheduled on courts next to or near contract courts.
18. Involvement in all activities shall be undertaken by you and your group member's own risk.
19. All contract fees and memberships must be paid by September 1, 2011. If not received by this date, Frog Hollow Racquet Club reserves the right to sell your court time and your deposit will be forfeited. No partial payments will be accepted
20. The contract captain is responsible for obtaining signatures from all of the contract players in your group.
